# Help with completing your CREST form

This is a guide to help you complete a CREST transfer form in order to convert a paper share certificate into an electronic share holding.

Insert the name of the company as it appears on your share certificate

Enter your Selftrade Account Number (7 or 8 digits)

Write in the type of security, for example 10p Ordinary Shares (this should be shown on the certificate).

Write the amount of shares you wish to transfer. You do not have to transfer the entire certificate.

Give the name and address of the owner(s) known to the register (this should be shown on the certificate)

All owners need to sign this form
